



TAKE-BACK OBLIGATION BATTERIES

Is your company subject to this legislation?

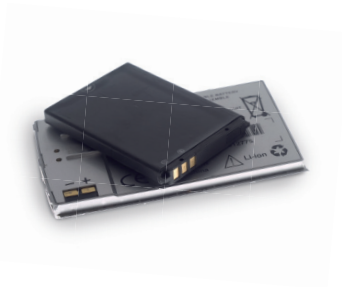


**DO YOU MANUFACTURE OR
IMPORT BATTERIES AND/OR
PRODUCTS CONTAINING BATTERIES
AND DO YOU PUT THEM ONTO
THE BELGIAN MARKET ?**

**THEN YOU ALSO HAVE A
RESPONSIBILITY TO FULFIL WHEN
THE BATTERY IS END-OF-LIFE.**

A growing number of products come with one or multiple batteries. Just think of greetings cards with music, clothing, e-cigarettes, (sports) watches, gadgets and other electric appliances for domestic or professional use. Then there are also electrically powered vehicles such as electric bicycles/scooters/steps/hoverboards, ... and hybrid and electric vehicles but also stationary batteries for energy storage (power banks, UPS, solar panels, ...). **Batteries are literally everywhere.**

Odds are that your company is importing (or manufacturing) batteries and putting them onto the Belgian market. In that case the **take-back obligation** applies. The latter is the result of the European Battery Directive 2006/66/EC that was transpositioned in our federal and regional legislations.



Everyone who imports (or manufactures) batteries (separately or built-in) and sells/leases/ makes them available in Belgium is considered a 'manufacturer' under this legislation and has a legal obligation to:

- **register**
- **declare** the number of batteries sold
- **raise public awareness** and take the necessary **preventative measures**
- set up an extensive collection system for **discarded batteries**, not just for the batteries they themselves put onto the market but also to accept discarded batteries from other manufacturers/importers that are handed in. Even non-customers can hand in discarded batteries in any shop.
- have the collected batteries **processed** by a recycler who meets the provisions of all 3 regional legislations
- prove that the recycler meets the minimum **level of recycling efficiency** imposed by Europe and regional legislations
- **report to the 3 governments** on the above obligations

ARE YOU CERTAIN YOU ARE NOT SUBJECT TO THIS LEGISLATION?

HOW CAN I MEET THIS LEGISLATION?

There are two **ways to meet this legislation**. The first is to submit an individual waste prevention and management plan to the regional authorities for approval. The second is for your company to become a participant of Bebat vzw.

Bebat will fulfil your obligations so your (large or small) business doesn't have to worry about a thing.

WHAT CAN BEBAT DO FOR YOU?

Bebat:

- fulfils your regional **registration** obligation
- organises **extensive awareness campaigns** and takes the necessary **preventative measures**
- takes care of the collection*: Bebat operates more than 24,000 collection points
- **gives advice** at collection points on how to handle batteries
- **provides free means of collection***
- takes care of **recycling** with proof of **recycling efficiency***
- submits regional **reports** to the competent governments
- provides **safe** transportation, storage and processing*

Bebat offers tailor-made solutions for batteries > 20kg (for lead batteries > 3kg) subject to an administrative fee.

WHAT DO WE NEED YOU TO DO FOR US?

All you need to do is **to declare** the number of batteries put onto the Belgian market on our online platform myBatbase. You can declare the number of batteries once a year (< 10,000 batteries) or once a month (≥ 10,000 batteries).

* for batteries subject to an environmental contribution. This is the case for all batteries ≤ 20kg (for lead batteries ≤ 3kg).



HOW TO BECOME A PARTICIPANT OF BEBAT

You can register your business online and sign the Participation Agreement with Bebat.



WHAT ARE THE RATES?

You pay an **annual fee** of €60 (VAT excl.). In addition you pay an overall **environmental contribution** for batteries ≤ 20kg (for lead batteries ≤ 3kg) and an **administrative contribution** for batteries > 20kg (lead batteries > 3kg). In the latter case Bebat will discuss with you how to organise the collection and recycling of these waste batteries.

WHAT IF I DON'T COMPLY?

It's best to comply as soon as you start manufacturing or importing (separate or built-in) batteries and putting them onto the Belgian market. If you do this later you will have to pay **retroactive contributions**. The regional authorities also check so-called free riders.

AS AN END SELLER DO I HAVE TO REGISTER AS A BEBAT COLLECTION POINT?

If you sell batteries to end users (consumers or companies) this means you are subject to the take-back obligation. The easiest way to comply is by becoming a free Bebat collection point.
